

# WHITE NOISE

## REHEARSAL & RECORDING STUDIO

These terms and conditions ("Terms") govern the use of the music rehearsal space White Noise Studios provided by Reaper Events Limited ("Provider"). By accessing or using the Space, you agree to abide by these Terms. If you do not agree with any part of these Terms, you may not use the Space.

### 1. **Booking and Reservations:**

1.1. Users must book the Space in advance through the designated booking system or by contacting the Provider directly.

1.2. Bookings are subject to availability and approval by the Provider.

1.3. The duration of each booking session is specified at the time of reservation and must be adhered to by the user.

### 2. **Payment:**

2.1. Users agree to pay the applicable fees for the use of the Space as determined by the Provider.

2.2. Payment must be made in full online prior to or as agreed with the owner.

2.3. Failure to make payment may result in the cancellation of the booking.

### 3. **Use of Space:**

3.1. The Space is to be used solely for music rehearsal purposes unless agreement has been made in advance with the owner.

3.2. Users must respect the equipment and facilities provided within the Space and use them in a proper and safe manner following all written and verbal instructions given.

3.3. Any damage to the Space or equipment must be reported to the Provider immediately, and users may be held responsible for repair or replacement costs.

### 4. **Conduct:**

4.1. Users must conduct themselves in a respectful and courteous manner while on the Provider's premises.

4.2. Noise levels must be kept at a reasonable level so as not to disturb others using adjacent spaces or neighboring properties.

4.3. Any behavior deemed disruptive or inappropriate by the Provider may result in the immediate termination of the booking and removal from the premises.

### 5. **Safety and Liability:**

5.1. Users are responsible for their own safety and the safety of others while using the Space.

5.2. The Provider is not liable for any injuries, accidents, or damages that occur as a result of the use of the Space.

5.3. Users are advised to obtain their own insurance coverage for any valuable equipment or instruments brought into the Space.

### 6. **Cancellation and Refunds:**

6.1. Cancellations must be made at least 48 hours in advance of the booked session to qualify for a full refund.

6.2. Refunds may be subject to a cancellation fee as determined by the Provider.

6.3. Refunds will not be issued for cancellations made less than 24 hours before the booked session unless agreed with the owner.

### 7. **Changes and Modifications:**

7.1. The Provider reserves the right to modify or terminate the availability of the Space, including but not limited to changes in operating hours or fees.

7.2. Users will be notified of any changes to these Terms or the availability of the Space in a timely manner.

### 8. **Governing Law:**

8.1. These Terms shall be governed by and construed in accordance with the laws of country.

By using the Space, you acknowledge that you have read, understood, and agreed to abide by these Terms. Failure to comply with these Terms may result in the termination of your booking and/or additional penalties as determined by the Provider.
