Terms and Conditions for Rehearsal Studio Hire – White Noise Studios

Effective Date: 01/06/2026

By booking and using the rehearsal facilities at White Noise Studios, you agree to be bound by the following Terms and Conditions.

Please read them carefully.

1. Booking and Payment

1.1. Booking Confirmation: All bookings are subject to availability and will only be confirmed upon receipt of full payment or a non-refundable deposit as specified at the time of booking via our website – www.whitenoisestudios.uk

1.2. Payment: Full payment for the booked session(s) must be received prior to the commencement of the session.

1.3. Cancellations:

* 48 hours or more notice: Full refund or reschedule.

* 24-48 hours notice: 50% refund or reschedule at the Studio's discretion.

* Less than 24 hours notice: No refund or reschedule.

1.4. Late Arrival/Early Departure: No refunds or extensions will be given for late arrival or early departure from a booked session.

2. Use of Studio Facilities and Equipment

2.1. Permitted Use: The Studio facilities, including all equipment, are provided solely for the purpose of musical rehearsal. Any other use must be explicitly agreed upon in writing by the Studio prior to the session.

2.2. Client Responsibility: The Client is responsible for ensuring that all members of their party use the Studio and its equipment safely and responsibly.

2.3. Equipment Care: All Studio equipment (including but not limited to amplifiers, drum kits, microphones, PA systems) must be treated with care. Clients should report any existing damage or malfunction to staff immediately upon entering the studio before the session begins.

2.4. No Unauthorised Modifications: Clients are strictly prohibited from altering, unplugging, re-wiring, or tampering with any Studio equipment or electrical installations without explicit permission from Studio staff.

2.5. Cleanliness: Clients are expected to leave the Studio space in a clean and tidy condition. All rubbish must be placed in the bins provided. An additional cleaning fee may be charged if the Studio is left in an unacceptable state.

3. Studio Equipment Usability and Liability

3.1. "As Is" Basis: Studio equipment is provided on an "as is" basis. While we strive to maintain all equipment in good working order, mechanical and electrical failures can occur.

3.2. No Responsibility for Unusability: In the event that any piece of Studio equipment becomes unusable or malfunctions during your session, White Noise Studios will not be held responsible for any resulting disruption to your rehearsal.

3.3. No Refunds or Compensation: No refunds, partial refunds, or compensation will be provided for sessions where Studio equipment becomes unusable or malfunctions during the booked period.

3.4. Reporting Faults: Clients are encouraged to report any equipment issues to Studio staff immediately. We will endeavour to offer assistance or alternative solutions where available, but this is not guaranteed and does not negate clause 3.3.

3.5. The Hirer acknowledges and agrees that the booking and associated hire fee pertain exclusively to the use of the physical rehearsal room. Any musical instruments, backline, or supplementary equipment located within the space are provided strictly as discretionary, added items and do not form part of the core hire agreement. The Company makes no guarantees regarding the presence, working condition, or suitability of these additional items. Furthermore, the unavailability, malfunction, or removal of any such instruments or equipment during the scheduled rehearsal period shall not constitute a breach of these Terms and Conditions, nor shall it entitle the Hirer to any refund, discount, or compensation.

4. Damages and Liability

4.1. Damage to Property: The Client is fully responsible for any and all damage caused to the Studio premises, equipment, fixtures, or fittings by themselves or any member of their party.

4.2. Payment for Damages: The Client agrees to pay the full cost of repair or replacement for any such damages. This payment must be made within 7 days of notification from the Studio.

4.3. Personal Property: The Studio accepts no responsibility for the loss or damage to any personal belongings or equipment brought onto the premises by the Client or their party.

4.4. Insurance: Clients are advised to have their own insurance to cover personal equipment.

5. Health, Safety, and Conduct

5.1. CCTV in Operation:

* For the safety and security of our clients, staff, and property, please be advised that White Noise Studios operates 24-hour Closed-Circuit Television (CCTV) surveillance throughout the premises, including all rehearsal rooms and common areas.

* By entering the Studio, you consent to being recorded by our CCTV system.

* Recordings are kept securely and accessed only when necessary for security, health & safety, or investigation of incidents.

5.2. No Smoking/Vaping: Smoking or vaping is strictly prohibited anywhere inside the Studio premises.

5.3. Alcohol/Drugs: The consumption of illegal drugs is strictly forbidden. The Studio reserves the right to refuse entry or terminate a session without refund if a client or their party is deemed to be under the influence of illegal substances or excessively intoxicated.

5.4. Noise Levels: While rehearsing, Clients are expected to manage noise levels responsibly and not cause disturbance to other users or neighbours.

5.5. Refusal of Service: The Studio reserves the right to refuse service or terminate a session without refund if these Terms and Conditions are breached, or if the conduct of the Client or their party is deemed unacceptable or unsafe.

6. Governing Law

6.1. These Terms and Conditions shall be governed by and construed in accordance with the laws of England and Wales.
